<u>CASE SUMMARY</u>- On the evening of October 15, 2024, the suspect entered the QuikTrip convenience store at approximately 9:00 pm. The store was manned by a single employee, Jane Smith. The suspect approached the counter and demanded that Smith hand over all the money in the cash register. When Smith hesitated, the suspect, produced a firearm and threatened to shoot her if she did not comply. Fearing for her life, Smith opened the cash register and handed over approximately \$500.00 in cash.

Mark Johnson, entered the store. The suspect, still brandishing the firearm, assaulted Johnson, striking him in the head with the gun. Johnson sustained a concussion and required medical attention. The suspect then fled the scene in a Black Ford F-150.

<u>CHARGE-</u> Aggravated Robbery (Texas Penal Code § 29.03), Assault with a deadly weapon (Texas Penal Code § 22.02)

DEFENDANT- Mason Carlisle

LEGAL PROCEEDINGS-

Arrest: Mason Carlisle was arrested on October 17, 2024 at his home without incident.

Indictment: The Grand Jury indicted Mason Carlisle on charges of Aggravated Robbery and Assault with a Deadly Weapon on November 1, 2024.

Plea Hearing: Carlisle entered a plea of not guilty at his arraignment on November 10, 2024.

Pre-Trial Motions: The defense filed a motion to suppress the surveillance footage, arguing that it was obtained without a warrant. The court denied the motion, ruling that the footage was admissible as it was recorded in a public place.

Trial: The trial is set to begin on January 11th, 2025, in the Travis County District Court.

- The defendant was administered Miranda warnings before making any statements/confessions.
- There are no legal problems with collecting or storing any physical evidence.
- There is no legal problem with the chain of custody of any physical evidence.

The Grand Jury for the State of Texas, upon its oath, does present that on or about the 15th day of October 2024, in the County of Travis in the State of Texas, Mason Carlisle, hereinafter called the Defendant, did then and there in the course of committing theft of property owned by Jane Smith, intentionally and knowingly exhibit a deadly weapon, to wit: a firearm, during the commission of and in the immediate flight from the theft.

This conduct constitutes the offense of Aggravated Robbery, a first-degree felony, in violation of Texas Penal Code § 29.03

Count II: Assault with a deadly weapon

The Grand Jury for the State of Texas, upon its oath, does further present that on or about the 15th day of October 2024, in the County of Travis in the State of Texas, Mason Carlisle, hereinafter called the Defendant, did then and there intentionally, knowingly, or recklessly cause serious bodily injury to Mark Johnson and did then and there use and exhibit a deadly weapon, to wit: a firearm, during the commission of the assault.

This conduct constitutes the offense of Aggravated Assault with a Deadly Weapon, a second-degree felony, in violation of Texas Penal Code § 22.02.

INTERVIEW OF JANE SMITH

October 15, 2024, 11:00 pm (QuikTrip Convience Store)

Interviewing Officer: Sarah Bradshaw, Badge No. 568, Austin Police Department

Officer Sarah Bradshaw: Can you please state your full name and date of birth?

Jane Smith: My name is Jane Smith, and I was born on July 12, 1985.

Officer Sarah Bradshaw: Thank you, Jane. Can you please describe what happened here tonight?

Jane Smith: Sure. I was working the night shift and I was the only employee on duty. Around 9:00 PM, a man entered the store. He was tall, with short dark hair, and he was wearing a black hoodie, dark jeans, and sneakers. I didn't think much of it at first, but as he approached the counter, I noticed he looked nervous and his hands were shaking.

Officer Sarah Bradshaw: Did he say anything to you?

Jane Smith: Yes, he came up to the counter and demanded that I give him all the money in the cash register. He said, "Give me all the money, or I'll shoot you." I was scared and didn't want to risk my life, so I opened the cash register and started handing him the money. He was holding a small handgun, and it was pointed at me the entire time.

Officer Sarah Bradshaw: Can you describe the weapon he was holding?

Jane Smith: It was a small handgun, probably a revolver. It was black and looked like it could do serious damage. I was so scared that I didn't look at it closely, but I remember it being shiny and pointed directly at me.

Officer Sarah Bradshaw: What happened next?

Jane Smith: As I was handing him the money, a customer, who I now know is Mark Johnson, entered the store. The man with the gun turned around to flee when he heard Mark enter. He got angry and raised the gun, striking Mark in the head with the butt of it. Mark fell to the ground, and I could see that he was bleeding and in pain. The man then stuffed the gun into his hoodie pocket and ran off.

Officer Sarah Bradshaw: Did you see the man leave the store?

Jane Smith: Yes, I saw him run out the front door. He looked back at me and Mark before he left, and then he was gone. I immediately called 911 and tried to help Mark. He was conscious but in a lot of pain. Your guys arrived a few minutes later, and I gave them a description of the man and the vehicle he was driving, which was a black Ford F-150.

Officer Sarah Bradshaw: Can you provide a more detailed description of the man?

Jane Smith: He was tall, around 6 feet, with short dark hair. He had a thin build and was wearing a black hoodie, dark jeans, and black sneakers. He had a nervous and aggressive demeanor, and his hands were shaking. I didn't see his face clearly because he was wearing a hoodie, but I can recognize him if I see him again.

Officer Sarah Bradshaw: Thank you, Jane. Your statement has been very helpful. Is there anything else you would like to add?

Jane Smith: No, I think that covers everything. I just hope you catch him soon. I was really scared, and I don't want anyone else to go through what I did.

Officer Sarah Bradshaw: We will do our best to bring him to justice. Thank you for your cooperation. Would you be willing to provide a written statement for our records?

Jane Smith: Yes. I can write one now.

WRITTEN STATEMENT OF JANE SMITH

On the evening of October 15, 2024, I was working the night shift at the convenience store. I was the only employee on duty. Around 9:00 pm, a man entered the store. He was tall, around 6 feet, with short dark hair, and he was wearing a black hoodie, dark jeans, and black sneakers. He looked nervous and his hands were shaking.

As he approached the counter, he demanded that I give him all the money in the cash register. He said "Give me all the money, or I'll shoot you." He was holding a small black handgun, which I believe was a revolver. He had it pointed at me the whole time. I was scared and didn't want to risk my life, so I opened the cash register and started handing him money.

While I was handing him the money, a customer, entered the store. The man with the gun heard the customer enter and turned to flee. He got angry and raised the gun, striking the customer in the head with the butt of the gun. The customer fell to the ground, and I could see that he was bleeding and in pain. I immediately called 911 and the man left. I tried to help the customer, who was conscious but in a lot of pain. The police arrived a few minutes later, and I gave them a detailed description of the man and the vehicle he was driving, which was a black Ford F-150. I would recognize the man if I saw him again.

Interviewing Officer: Sarah Bradshaw, Badge No. 568, Austin Police Department

Officer Sarah Bradshaw: Can you please state your full name and date of birth?

Mark Johnson: My name is Mark Johnson, and I was born on March 12, 1975.

Officer Sarah Bradshaw: Thank you, Mark. Are you feeling well enough to tell me what occurred earlier this evening?

Mark Johnson: Yes, my head hurts, but I have been given pain medication.

Officer Sarah Bradshaw: Please describe what happened at the convenience store earlier this evening.

Mark Johnson: Sure. I went to the QuikTrip around 9:00 pm. I was on my way home from work and I wanted a snack. When I entered the store, I saw a man standing at the counter with the employee. The man was pointing a gun at her and looked very aggressive.

Officer Sarah Bradshaw: Can you describe the man and the weapon he was holding?

Mark Johnson: The man was tall, around 6 feet, with short dark hair. He was wearing a black hoodie, dark jeans, and black sneakers. He had a small black revolver in his hand. He looked nervous and agitated.

Officer Sarah Bradshaw: What happened next?

Mark Johnson: I think the man heard me enter. He turned to leave and about ran me over. This made him more agitated. He raised the gun above my head. He said, "Get out of my way, or I'll shoot you!" I was really scared and tried to back away, but before I could fully react, he swung the gun and hit me in the head with the butt of it. I fell to the ground and hit my head on the floor. I was in a lot of pain and could feel blood on my head.

Officer Sarah Bradshaw: Can you describe what happened after you were hit?

Mark Johnson: I was on the ground trying to get up, but was in a lot of pain. The man shoved the gun in his pocket and ran out of the store. I saw him leave through the front door and get into a black Ford F-150 truck. He drove away quickly.

Officer Sarah Bradshaw: Did you see the man's face?

Mark Johnson: Not very clearly. He was wearing a hoodie, and his face was mostly covered. But I think I can recognize him If I see him again. He had short dark hair and was tall and thin.

Officer Sarah Bradshaw: Was anyone else in the store at the time?

Mark Johnson: No, it was just the cashier and myself. She looked very scared and was trying to help me

after the man left. She called 911, and then the police and ambulance arrived shortly after that.

Officer Sarah Bradshaw: Do you have any other information that might be helpful to our investigation?

Mark Johnson: I don't think so. I just hope you catch the guy. He seems dangerous.

Officer Sarah Bradshaw: Thank you, Mark. Your statement has been very helpful. We will do everything we can to catch this guy. If you have any further information or if you remember anything else, please don't hesitate to contact us.

Mark Johnson: Thank you, officer. I appreciate your help.

Initial Assessment

Presenting Complaint: Head injury and concussion following an assault.

Chief Complaint: Severe headache, dizziness, and a laceration on the right side of the head.

History of Present Illness:

Mark Johnson, 48 year old male, was brought to the emergency department by Austin Fire Department (AFD) EMS unit 12 following an incident at a convenience store. According to the patient and bystanders, he was struck on the head with the butt of a firearm by an assailant. He fell to the ground and hit his head on the floor, resulting in a laceration and significant pain.

Physical Examination:

General- Alert and oriented to person, place, and time. Distressed due to pain.

Head- A 5 cm laceration on the right parietal region with active bleeding. No visible deformities or swelling.

Eyes- Pupils equal, round, and reactive to light. No signs of retinal hemorrhage.

Ears, Nose, Throat-No visible trauma, clear airway.

Neck- No tenderness or deformity.

Chest-Clear breath sounds bilaterally, no rib tenderness.

Abdomen-Soft, non-tender, no organomegaly.

Extremities- No visible injuries, full range of motion.

Neurological- Cranial nerves II-XII intact. Motor strength 5/5 in all extremities. Reflexes 2+ and symmetric. No focal deficits.

Diagnostic Tests:

CT Scan of the Head- No evidence of intracranial hemorrhage, skull fracture, or midline shift.

X-Ray of the Skull- No fractures.

Complete Blood Count (CBC)- Within normal limits.

Metabolic Panel-Within normal limits.

Drug Screen- Negative for alcohol or drugs of abuse.

Treatment:

Wound Care-

The laceration was cleaned with an antiseptic solution. Local anesthesia (lidocaine 1%) was administered. The wound was sutured with a 4-0 non-absorbable sutures. A sterile dressing was applied to the wound.

Pain Management:

Advised the patient to avoid strenuous activities and cognitive tasks for the next 24-48 hours. Prescribed acetaminophen 650 mg every 6 hours as needed for pain. Recommended follow-up with primary care physician in 1-2 weeks for re-evaluation.

Discharge Instructions:

- Activity: Rest and avoid strenuous activities or cognitive tasks for the next 24-48 hours.
- Diet: Normal diet.
- Follow-Up: Schedule an appointment with a primary care physician in 1-2 weeks.
- Medications:
 - Acetaminophen 650 mg every 6 hours as needed for pain.
- No driving or operating heavy machinery for the next 24-48 hours.
- Monitor for symptoms of worsening headache, vomiting, or changes in mental status. If any of these symptoms occur, return to the emergency department immediately.

Discharge Condition:

The patient was stable, alert, and oriented. He was able to walk with assistance and follow discharge instructions.

This report documents the results of the fingerprint analysis conducted on the latent print lifted from the back of the cash register at the QuikTrip convenience store. The analysis was performed to determine the identity of the individual who left the fingerprint.

Method:

Sample Collection- The latent fingerprint was lifted from the back of the cash register using standardized lifting techniques, including the use of fingerprint powder and lifting tape. The lift was completed by officers on the scene. The lifted print was adhered to a fingerprint backing card, packaged, and transported to the laboratory for analysis.

The latent print was analyzed using a high-resolution digital scanner to capture detailed images. The images were then processed using the Automated Fingerprint Identification System (AFIS) to compare the latent print against the database.

The latent print was compared to known fingerprints of individuals involved in the case, including Jane Smith.

The comparison revealed a high degree of similarity between the latent print and the known fingerprints of Mason Carlisle. I was able to identify 12 matching minutiae (points of identification).

Jane Smith: Yes, I saw him run out the front door. He looked back at me and Mark before he left, and then he was gone. I immediately called 911 and tried to help Mark. He was conscious but in a lot of pain. The police arrived a few minutes later, and I gave them a detailed description of the man and the vehicle he was driving, which was a black Ford F-150.

Prosecutor: Can you provide a more detailed description of the man?

Jane Smith: He was tall, around 6 feet, with short dark hair. He had a thin build and was wearing a black hoodie, dark jeans, and black sneakers. Direct Examination by the Prosecution

Prosecutor (Jessica Santos): Good morning, Officer Bradshaw. Can you please state your full name and badge number for the record?

Officer Sarah Bradshaw: Good morning. My name is Sarah Bradshaw, and my badge number is 568.

Prosecutor: Thank you, Officer Bradshaw. On the evening of October 15, 2024, were you on duty in the area of 861 East Braker Lane in Austin, Texas?

Officer Sarah Bradshaw: Yes, I was on duty in that area on the evening of October 15, 2024.

Prosecutor: Can you please describe what happened when you received the call about the incident at the QuikTrip convenience store?

Officer Sarah Bradshaw: At approximately 9:05 PM, I was dispatched to a call at the QuikTrip convenience store at 861 East Braker Lane. The caller, Jane Smith, reported a robbery and assault. She stated that a man had entered the store, threatened her with a firearm, and demanded money from the cash register. She also reported that the man had assaulted a customer before fleeing the scene in a black Ford F-150.

Prosecutor: Can you describe your arrival at the scene and your initial assessment?

Officer Sarah Bradshaw: I arrived at the scene at 9:07 PM. I conducted a preliminary assessment of the situation. Jane Smith, the employee, was visibly shaken but not physically injured. I observed Mark Johnson, a customer, on the ground, bleeding from a head wound. I secured the area.

Prosecutor: Can you describe the evidence you collected at the scene?

Officer Sarah Bradshaw: I collected several pieces of evidence. The cash register was open, and cash appeared to have been removed. I also collected fingerprints from the back of the cash register and

secured them for transport to the laboratory. I captured a single still image from the surveillance cameras.

Prosecutor: Did you interview any witnesses at the scene?

Officer Sarah Bradshaw: Yes, I interviewed Jane Smith at the scene. She provided a detailed description of the incident, including the appearance of the suspect and the vehicle he was driving. I also interviewed Mark Johnson at Memorial Heights Hospital later that evening.

Prosecutor: Can you summarize the statements of Jane Smith and Mark Johnson?

Officer Sarah Bradshaw: Jane Smith described the suspect as a tall man, around 6 feet, with short dark hair, wearing a black hoodie, dark jeans, and black sneakers. He was nervous and his hands were shaking. He demanded money from the cash register and threatened her with a small black handgun. When Mark Johnson entered the store, the suspect turned and struck him in the head with the butt of the gun. Both victims provided a consistent description of the suspect and the vehicle he was driving, a black Ford F-150.

Prosecutor: Did you take any additional actions that evening?

Officer Sarah Bradshaw: Yes, I broadcasted an ATL (Attempt to Locate) for the black Ford F-150 on the primary radio channel at 9:15 PM. I also conducted a preliminary crime scene investigation and secured the area until the crime scene unit arrived. I interviewed Jane Smith at the scene at 11:00 PM and Mark Johnson at Memorial Heights Hospital at 11:45 PM.

Prosecutor: Thank you, Officer Bradshaw. No further questions.

Cross-examination by the Defense

Defense Attorney (Xavier Nguyen): Good morning, Officer Bradshaw. Can you confirm that when you arrived at the scene, Jane Smith was the only employee on duty?

Officer Sarah Bradshaw: Yes, Jane Smith was the only employee on duty.

Defense Attorney: You mentioned that Jane Smith was visibly shaken but not physically injured. Can you describe her state of mind in more detail?

Officer Sarah Bradshaw: Jane Smith was visibly shaken and appeared to be in a state of shock. She was nervous and her hands were trembling. She was cooperative and provided a detailed account of the incident.

Defense Attorney: You also captured a still image from the surveillance cameras. Can you describe the quality of this image?

Officer Sarah Bradshaw: The image was of sufficient quality to capture the suspect's actions and the general appearance of the suspect. It showed the suspect approaching the counter, demanding money. The image was clear enough to identify the suspect's clothing and the weapon he was holding.

Defense Attorney: You mentioned that you interviewed Mark Johnson at the hospital. Can you confirm if he was under the influence of any medication during the interview?

Defense Attorney (Xavier Nguyen): Mr. Johnson, you mentioned that the man was nervous and his hands were shaking. Can you confirm if you saw any other signs of nervousness or agitation, such as sweating or rapid breathing?

Mark Johnson: He was definitely nervous. His hands were shaking, and he was speaking quickly. I didn't notice any sweating or rapid breathing, but he seemed very agitated and scared.

Defense Attorney: Thank you, Mr. Johnson. No further questions.

Judge (Honorable John Vincent):

Thank you, Mr. Johnson. You may step down.

Direct Examination by the Defense

Defense Attorney (Xavier Nguyen): Good afternoon, Officer Cooper. Can you please state your full name and badge number for the record?

Officer Alex Cooper: Good afternoon. My name is Alex Cooper, and my badge number is 570.

Defense Attorney: Officer Cooper, can you describe your role and responsibilities as an officer with the Austin Police Department?

Officer Alex Cooper: I am a patrol officer with the Austin Police Department. My primary responsibilities include responding to calls, conducting traffic stops, and ensuring the safety of the community.

Defense Attorney: In the early hours of October 16, 2024, you conducted a traffic stop on a Ford F-150. Can you describe the circumstances of that traffic stop?

Officer Alex Cooper: Yes, on the evening of October 15, 2024, I was on routine patrol in the area of 6100 Main Street, Austin, Texas. At approximately 11:59 pm, I observed a dark-colored Ford F-150 fail to come to a complete stop at a stop sign. The vehicle slowed down but did not come to a full stop before proceeding through the intersection. I initiated a traffic stop and followed the vehicle to a safe location on the side of the road.

Defense Attorney: Can you describe the driver of the vehicle?

Officer Alex Cooper: The driver of the vehicle was a male, later identified as Mason Carlisle. He appeared calm and cooperative. He provided his driver's license, vehicle registration, and proof of insurance.

Defense Attorney: Did you recognize the vehicle as being part of an ATL (Attempt to Locate) broadcast?

Officer Alex Cooper: No, I did not recognize the vehicle as being part of an ATL broadcast. I was not familiar with the specific details of the ATL at the time of the traffic stop.

Defense Attorney: Can you explain why you were not familiar with the ATL?

Officer Alex Cooper: On the evening of October 15, 2024, I was working on a special assignment and had not been on the same radio channel as the ATL broadcast. Additionally, I was not part of the team that was initially responding to the robbery and assault at the QuikTrip convenience store. I was not briefed on the details of that incident until after the traffic stop.

Defense Attorney: Did you conduct a criminal history check on the driver and the vehicle during the traffic stop?

Officer Alex Cooper: Yes, I conducted a criminal history check on Mason Carlisle and had dispatch run the plate number through the system. The check revealed no outstanding warrants or violations. The vehicle registration and insurance were valid and up-to-date.

Defense Attorney: What additional actions did you take during the traffic stop?

Officer Alex Cooper: I issued a traffic citation to Mason Carlisle for failing to come to a complete stop at a stop sign, in violation of Texas Transportation Code § 544.007. I also provided a verbal warning about the importance of following traffic laws and the potential dangers of distracted driving.

Defense Attorney: Thank you, Officer Cooper. No further questions.

Cross-examination by the Prosecution

Prosecutor (Jessica Santos): Good afternoon, Officer Cooper. You mentioned that you were not familiar with the ATL broadcast on the evening of October 15, 2024. Can you explain why you were not briefed on the details of the robbery and assault at the QuikTrip convenience store?

Officer Alex Cooper: As I mentioned, I was working on a special assignment and had not been on the same radio channel during the time the ATL was broadcast. I was not part of the initial response team and was not briefed on the details of the incident until after the traffic stop.

Prosecutor: You stated that you were not part of the team that initially responded to the incident. Can you confirm if you had any communication with other officers or dispatch about the ATL?

Officer Alex Cooper: No, I did not have any communication with other officers or dispatch about the ATL. I was not aware of the specific details of the incident until after the traffic stop.

Prosecutor: You mentioned that you conducted a criminal history check on Mason Carlisle and the vehicle. Did you notice any unusual activity or behavior from Mason Carlisle during the traffic stop that might have raised your suspicion?

Officer Alex Cooper: No, Mason Carlisle appeared calm and cooperative. He provided all the necessary documents and followed my instructions. There was no unusual activity or behavior that raised my

suspicion.

Prosecutor: You issued a traffic citation to Mason Carlisle for failing to come to a complete stop at a stop sign. Can you confirm if you observed any signs of nervousness or agitation from him during the traffic stop?

Officer Alex Cooper: No, Mason Carlisle did not appear nervous or agitated. He was calm and cooperative throughout the traffic stop.

Prosecutor: Thank you, Officer Cooper. No further questions.

Redirect Examination by the Defense

Defense Attorney (Xavier Nguyen): Officer Cooper, you mentioned that you were not familiar with the ATL because you were working on a different channel and had not been briefed on the incident. Can you explain how the "channels" work in the Austin Police Department?

Officer Alex Cooper: In the Austin Police Department, officers working on special assignments work on different radio channels, and regular patrol communication is handled on the primary channel. On the evening of October 15, 2024, I was working on a special assignment, while the officers who initially responded to the QuikTrip incident were on the primary channel. It is not uncommon for officers to be working on different assignments and not be immediately briefed on all incidents that occur during their shift.

Defense Attorney: Thank you, Officer Cooper. No further questions.

Re-cross Examination by the Prosecution

Prosecutor (Jessica Santos): Officer Cooper, you mentioned that you were not briefed on the details of the QuikTrip incident until after the traffic stop. Can you confirm if you have since received any training or updates on how to stay informed about ongoing investigations and ATL broadcasts?

Officer Alex Cooper: Yes, since the incident, I have received additional training on staying informed about ongoing investigations and ATL broadcasts. The department has emphasized the importance of communication and information sharing among officers, regardless of their assignments.

Prosecutor: Thank you, Officer Cooper. No further questions.

Judge (Honorable John Vincent):

Thank you, Officer Cooper. You may step down.
