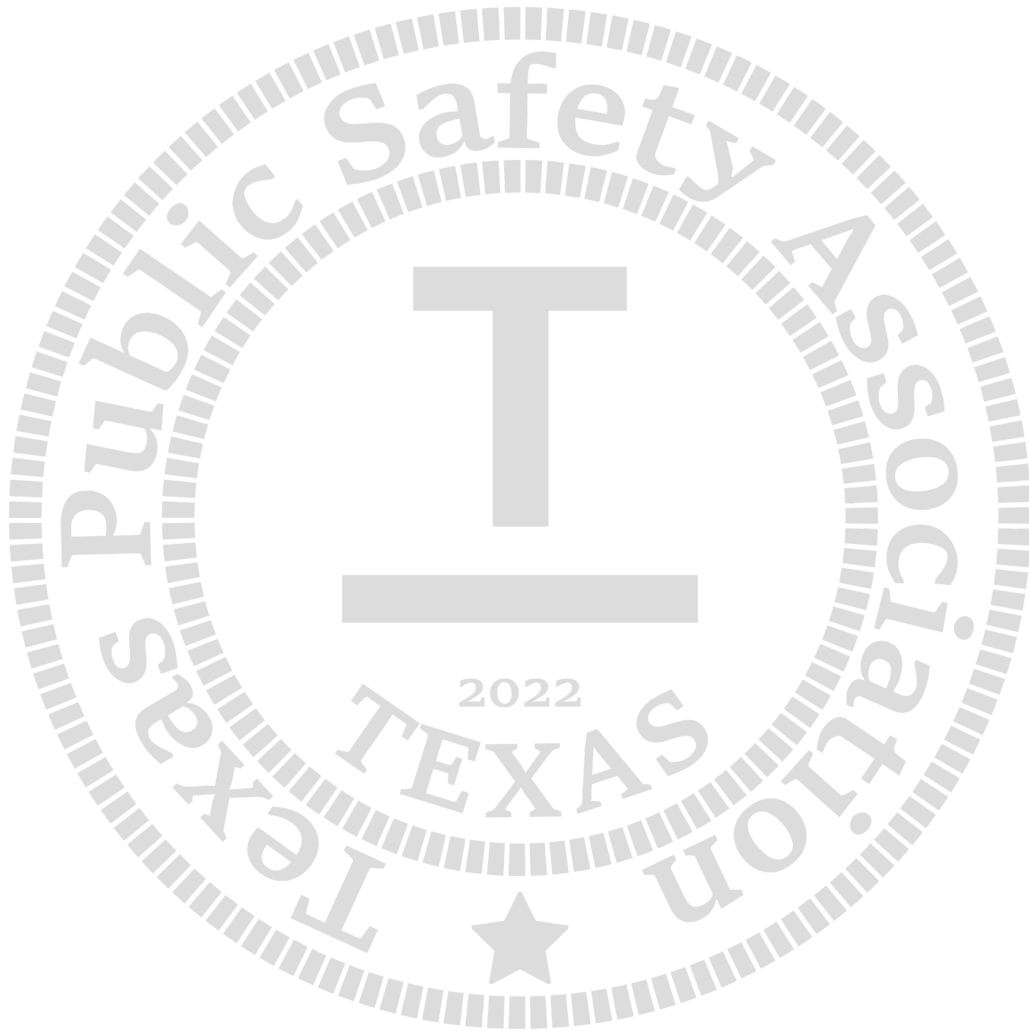

Hey Jordan,

Here's where we stand right now:

- **What Happened:** Fire appears to have been caused by an explosive device in Unit 205, which accelerated the spread and created structural challenges for suppression.
- **The Damage:** Fire contained to the second and third floors by 3:25 PM. Total of 12 units affected, with heavy smoke and water damage throughout.
- **Casualties:**
  - 1 confirmed fatality (Unit 213, smoke inhalation).
  - 2 injuries: One adult male transported for burns; one child treated and released on scene.
- **Challenges:**
  - No sprinkler system.
  - Witnesses are saying the alarms didn't go off, though we can't confirm that yet.
  - Several residents initially refused to evacuate, which delayed clearing Unit 312.
  - Radio traffic became congested around 2:50 PM, briefly delaying secondary resource deployment.

Law enforcement is now leading the investigation into the device. Coordination is ongoing.



I'll send a full report once we debrief, but this should cover the immediate need. Let me know if you need anything else.

Here's what we handled:

- Rescued three people (two adults, one child) from balconies on the third floor.
- Found one deceased female (Unit 213) during the secondary search—likely smoke inhalation.
- The third floor was tough. The explosion caused significant structural damage, making navigation hazardous on the third floor. Heavy smoke slowed us down further in the stairwell.
- We had minor pressure issues with our initial hose line, but it was resolved quickly.

Some residents mentioned the alarms weren't working, but I'm not sure how widespread that issue was. Let me know if you need anything else.

Here's what we handled:

- **Patients Evaluated:** Three total.
  - 1 adult male with burns and trauma injuries from the explosion, transported to Memorial General.
  - 1 child with minor injuries and smoke inhalation, treated on scene.
  - 1 adult female deceased on arrival—smoke inhalation.
- We initially thought we had four patients, but it turned out one was just a bystander overcome by anxiety.
- **Easy access:** We had clear visibility on the stairs leading to the third floor.

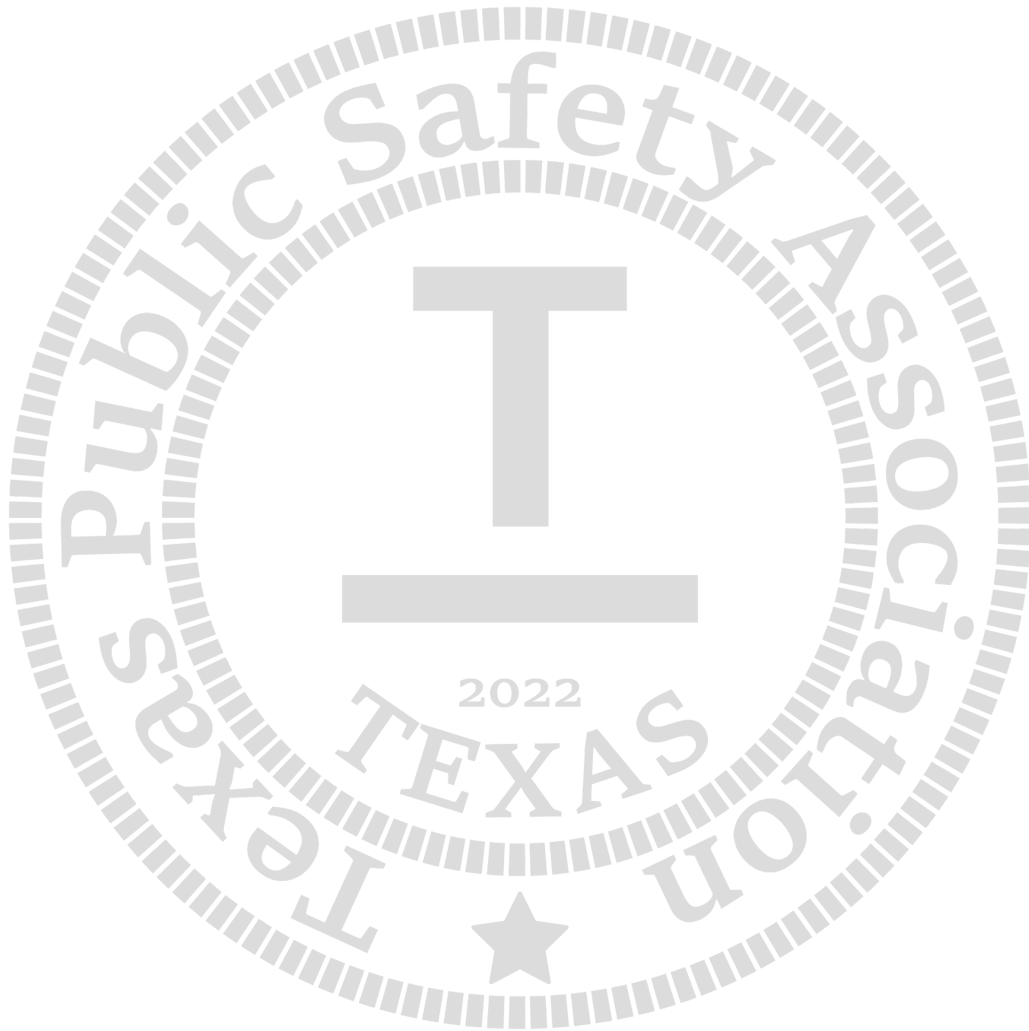

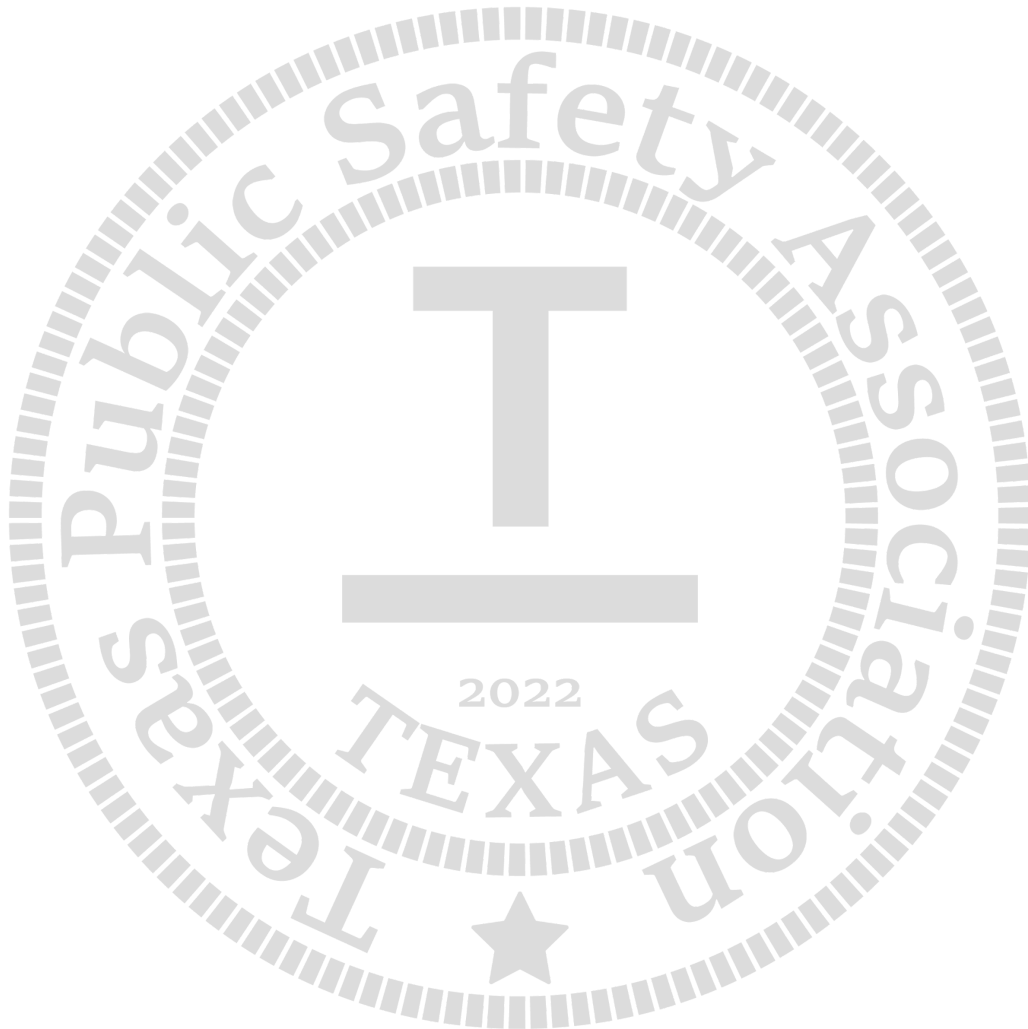
- The Command Unit assisted in coordinating ventilation operations with your crews and Oakwood FD. Which was challenging due to structural damage from the explosion.
